4. Details of our assessment

This was an unannounced site inspection carried out by Waste Regulation Team Leader Carys Williams and Hazardous Waste Officer Kathryn Bradshaw. The inspection was

carried out assess whether waste quantities onsite had increased, despite the sites permit being suspended for the acceptance of waste.

On arrival at site, it appeared that the Household, Commercial & Industrial waste stored on site was new, and not what was witnessed during the previous inspection.

Officers met with Site Manager Jamie, who accompanied officers around site. It was identified that the fire damaged waste had been returned to the 3rd bay from the left, however in front of the fire damaged waste was a new deposit of waste which was not involved in the fire.

Officers identified documents within the household, commercial and industrial waste which contained dates from after the permit was suspended. It was explained to the site manager that no waste should be accepted onto site. This message has been communicated to GTR Aggregates & Recycling Ltd and site operatives on several occasions.

It is an offence under EPR 2016, Regulation 38(3) To fail to comply with the requirements of an enforcement notice. The acceptance of waste is a breach of the notice in place. Investigations will continue and the appropriate enforcement response will be taken.

The height of the inert waste piles had decreased, this was completed following concerns raised by the Health & Safety Executive. Whilst the height of stockpiles had reduced in

some areas, the total quantity of inert waste on site remained a concern. This has previously been scored a Category 3 Breach against the permit. Inert waste quantities should be decreased below the 2000 tonne limit and removed from site.
