4. Details of our assessment

This was an unannounced site inspection carried out by Waste Regulation Team Leader Carys Williams and Waste Regulation Officer Amy Henderson. The inspection was carried out in response to a report that the waste quantities onsite had increased, despite the sites permit being suspended for the acceptance of waste.

Whilst Officers were arriving at the site a skip wagon was seen leaving the premises with an empty skip on it.

On arrival at site, Officers signed in at reception. A site employee advised Officers that site managers were not onsite at the time but advised Officers were able to walk around the site.

Food waste previously seen on site was still present, this was now at the back of other waste that had been deposited in the building. A pile of waste was seen in the yard area, this looked like it had been freshly deposited. There was still a lot of waste present in the barn areas. A site employee advised that loads of waste had been deposited and also left site today.

Documents were found in the waste containing dates from after the permit was suspended.

Staff were again advised that no waste should be brought onto site and a code b was issued.

It is an offence under EPR 2016, Regulation 38(3) To fail to comply with the requirements of an enforcement notice. The acceptance of waste is a breach of the notice in place. Investigations will continue and the appropriate enforcement response will be taken.
