1. Site report an infill of 68,000m³ between July 16-July17 leaving a void space of 5,961,000m³ as at July 2017.

2. Surface Water - Sampled Monthly, reported Quarterly for pH, Suspended Solids, Ammoniacal Nitrogen, and Chemical Oxygen demand.

NRW note that e reading of 8 was reached for March and August 17, but was not a breach of the limit. Insufficient flow was recorded for April and May. A higher than usual reading of 2.59mg/l for Amm Ni was seen in Dec 17, but this was still within limits meaning no breaches of permit conditions were levied for surface water for 2017.
