4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the regulating Natural Resources Wales (NRW) officer to review the submitted monitoring returns.

NRW received Q4 emissions monitoring by email on 17/01/23 as per permit requirements. Q4 monitoring returns covering the period from 01/10/2022 to 31/12/2022 for emissions to water were submitted by the required deadline as specified in Permit Condition 4.2.3(a).

Monitoring was undertaken as required by Permit Condition 3.3.1, Schedule 3(b), Table S3.2. All but one of the reported parameters for emission points W1 & W2 were compliant with the relevant emission limit values (elvs) specified by Permit Condition 3.1.2 and Schedule 3(b), Table S3.2 of the permit.

The instantaneous flow rate measurement recorded at W1 was in breach of the elv. The elv of 108 m³/hour was breached with a value of 125 m³/hour and an uncertainty of +/- 8% on 12/12/22. This hourly flow rate when extrapolated over a full day also had the potential to also breach the 24 hour elv of 2200 m³/day. A fully populated Schedule 5 Notification (parts A & B) was received by email on 13/12/22 within 24 hours of the breach with the results of the investigation and implemented resolution as per Permit Condition 4.3.1. The solenoid valves had frozen in cold weather conditions and this has been resolved with the installation of a heater and insulation.

Score: (E3) Surface Water. Permit Condition 3.1.2. Schedule 3(b), Table S3.2. CCS Score 3.

Action: No action. Resolution already implemented by operator.

A further Schedule 5 notification was received for emissions to air in Q4. This notification will be discussed when the air monitoring data for 2022 is submitted.
