3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A teams meeting with Lee Foulkes was held on the 18/01/2023 to discuss recent odour complaints. Present from NRW was Mostyn Wall and Ty Ward.

A H2S odour has been reported to the SW of the site. In response to the odour complaint Lee Foulkes has sent in updates of the sites activities and undertaken an early morning odour inspection near where the odour was reported. While investigating the odour complaint NRW found that the sites odour management plan has not been updated since 2006. A new version is required to reflect the present day operations and plans.

Action: The site to update the odour management plan.

The 2006 odour management plan states that weekly and monthly walkovers are undertaken to assess the air quality and investigate fugitive emissions. However no walkovers have been undertaken since 2018.

Action: Reinstate the walkover survey program. Site to send a proposal for site walkover monitoring. Including a site map showing locations of monitoring and monitoring frequency.

Walkover surveys will assess the sites infrastructure, presence of any fugitive emissions and provide an appropriate response to any future odour complaints.

Quarterly meetings

Quarterly meetings between NRW and the site will be re-instated to ensure regular dialogue between NRW and Bryn Pica landfill site.
