4. Details of our assessment

Forms S1, Emissions to Sewer, 1st January to 31st December 2022; E1, Energy Usage 2022; WU1, Water Usage 2022 and MR1, Mass Releases 2022, were received on 19th January 2023. Production was about 30% lower than in 2021. All the reports are accepted.

S1, Emissions to Sewer, 1st January to 31st December 2022

All emissions were within their respective emission limit values.

E1, Energy Usage 2022

Overall energy usage was less than in 2021 but about 10% more per unit of production. The electricity supplied to the Continental site comes from renewable sources. Continental have therefore not been able to provide an associated CO₂ production value. Some CO₂ will have been generated due to power losses in the transmission system.

R1, Waste Disposal and Recovery 2022

The total amount of waste sent for external treatment or to landfill was much less than in 2021. About half of this waste was recycled. The total amount of waste generated per unit of production was more than 50% lower than in 2021 because much less non filtercake waste was generated. The amount of filtercake produced was about 30% higher per unit of production, despite the overall amount being less than in the previous year.

WU1, Water Usage 2022

Total water use for the plating operation and associated processes was less than in 2021 but increased by just under 10% per unit of production.

MR1, Mass Releases 2022

Mass releases of cadmium and mercury were lower than in 2021. Both are well below the permitted concentrations. The releases per unit of production for both were higher than in 2021.

This has been another difficult year for industries supplying the automotive industry due to various supply issues and external factors beyond their control. Overall resource use and waste generation are lower than in 2021 but resource use and hazardous waste generation per unit of production are higher.

Natural Resources Wales hope that Continental may be able to identify and implement some measures to reduce resource use in 2023 and hope that the business situation improves.
