A site visit was undertaken on Monday 16 December 2023. Present at the time of the visit were: David Ellar and Sally Wakeford (NRW) and Damien Lloyd, HSEQ Manager (Swansea Drydocks Ltd).

No ships were currently being dismantled at site so a full inspection was unable to be undertaken. The site was clear and well managed but no permitted waste activities were being carried out.

The drainage was inspected and the channels were clear and free from contamination.
