### 4. Details of our assessment

Welsh Water Organic Energy (WWOE)

**EPR-AP3096CP**

As part of their response to BAT 36, mentioned in CAR Form CAR\_NRW0040817(Action 3), NRW received a composting trial proposal from Welsh Water Organic Energy (WWOE) on the 6<sup>th</sup> of January 2023. The proposal consists of trialling and comparing two different sized windrows (7m wide x 4m high v's 6m wide x 3m high). Monitoring technology, supplied by Compost Manager, will be used to measure a number of key parameters including – Oxygen, Carbon dioxide, moisture and temperature. A 2.5m probe has been obtained for this trial and will be used to collect readings from the centre of the windrows. The trial is being undertaken so that WWOE can measure the performance of the biological process against BAT and to assess actions required to maintain an optimum environment. NRW deem this a step in the right direction for achieving compliance with BAT. However, BAT 36 states: "In order to reduce emissions to air and to improve the overall environmental performance, BAT is to monitor and/or control the key waste and process parameters". These process parameters are then listed within the text of BAT 36. One of them is to control windrow porosity, height and width. NRW view the proposed trial as just the starting point of a transition to full BAT/Bref compliance, however, this may ultimately necessitate the use of smaller windrows. Therefore, following completion of these trials, if WWOE is unable to demonstrate reliable control and minimisation of release of odorous gases, including ammonia, NRW may require the use of smaller windrows as set out in the WT BRef.

The trial is due to start in March when sufficient and appropriate green waste material becomes available and is due to be repeated again in the summer under warmer drier conditions. NRW request that they be informed when these trials commence so that a decision can be made on viewing their progress.
