4. Details of our assessment

NRW carried out a routine site inspection to ensure that the Christmas and New Year management of the site was in place.

Site Inspector RT met the site Manager in the office and drove to the main viewing platform to see the open site. It was not possible at this inspection to visit the tipping face or the gas

engines due to a work instruction from NRW to RESTRICT access to potential gaseous areas due to issues with NRW gas alarm calibrations. This meant this inspection was limited in scope.

However, parts of the site were inspected visually.

Security - One entrance gate restrict and controls access to the site. The site perimeter fences were seen to be intact. All waste receipts are scheduled there are no unscheduled visits.

Birds - Some birds were present, but these were minimal. The site manages a small open tipping face which restricts numbers and covers fresh waste daily.

Vermin - non witnessed.

Noise - non witnessed

Odour - non witnessed

wind blown waste - the site was clean. Site has a good relationship with the neighbouring property's and volunteers to periodically pick up litter off site to the main road .



One common issue with the site insofar as the wider industry is that they are approached by potential customers to provide quotes for disposal of the waste. These quotes result in a

great deal of cost to the business and are then used by the customer to undercut Biffa.
