### 4. Details of our assessment

OSM sample taken on the 21st of December 2022 had a suspended solids result of 62mg/l compared to the permit limit of 60mg/l. The OSM sample taken on the 21st of December 2022 also had a BOD result of 95mg/l compared to the permit limit of 50mg/l.

This was the first suspended solids and BOD exceedance within the previous twelve months and is therefore within the allowable number under the look up table procedure.
