NRW's Geoscience Team have reviewed the above report and have made the following comments

Monitoring results generally satisfactory and data suggest no major changes.

There are a few exceedances of general things and you have looked into the discoloured water in more details which NRW welcomes. It appears that the discoloured water is not from hydrocarbon contamination – which is good to confirm.

However, it indicates a localised area of groundwater with conditions which are reducing (by oxidation) as it is positive Redox Potential values. This might be following the slug of low pH water that moved under the site a few years ago, when the metals in samples increase and pH dropped to 3 or 4. This started on the north of the site BH11 and moved southwards under the factory building and appearing out again in BH6, but this stabilised so this might be the remnants of this.

NRW recommends moving forward that your consultants provide details and reasoning and interpretation of the data and reasoning.

NRW also note that the trigger level at the sentry borehole was not exceeded this time around so there is no action plan given as we note it was below the trigger level this time around. We need to ensure we keep reviewing this during the monitoring.
