4. Details of our assessment

An unannounced inspection was carried out at Jays Metal. I was accompanied by Julie Young (operator).

The weather conditions were wet and windy

A full inspection could not be carried out because of the inappropriate storage of waste.

Category 3 breach of Section 2.3.1.a. Table S1.2

Storage of waste was non-compliant with S2.3.1 (a): *The activities shall be operated using the techniques and in the manner described in the documents specified in Schedule 1 Table 1.2*

Waste was not being stored in the manner or locations specified within the Environment Management System (EMS) and Fire Prevention and Mitigation Plan (FPMP). Waste was being stored in areas that would obstruct access by the Fire and Rescue Service.

- Batteries were being stored outside and not in the designated area, although they were stored in a chemical resistant container with a lid.
- Tyres should be stored in a shipping container in area A6. This area was impossible to access because of the waste stored in that area.
- Storage of waste prevented access to the building used to treat of ELVs.
- Access to the monitoring locations was restricted because of the inappropriate storage of waste.

It is essential to operate the site as described in the EMS and FPMP.

1.1 General Management

Condition 1.1.4 requires the that the operator complies with the requirements of an approved competence scheme. Julie Young has completed the continuing competence with WAMITAB which expires on 2 December 2023.

3.1.2.b.Emissions and Monitoring

It is essential that monitoring is carried out as described in the emissions monitoring plan as residential properties within the vicinity rely of private water supplies.

Please provide all the laboratory reports from the monitoring undertaken at Spring Well 1 and Spring Well 2 by 23 March 2022.

The discharge from the interceptor could not be inspected as it is located within a pig pen. You must ensure that the interceptor and discharges from the interceptor are accessible for inspection.
