River Taff just above M4 road bridge next to Taff trail. Big CSO discharge of brown sewage smelling water.

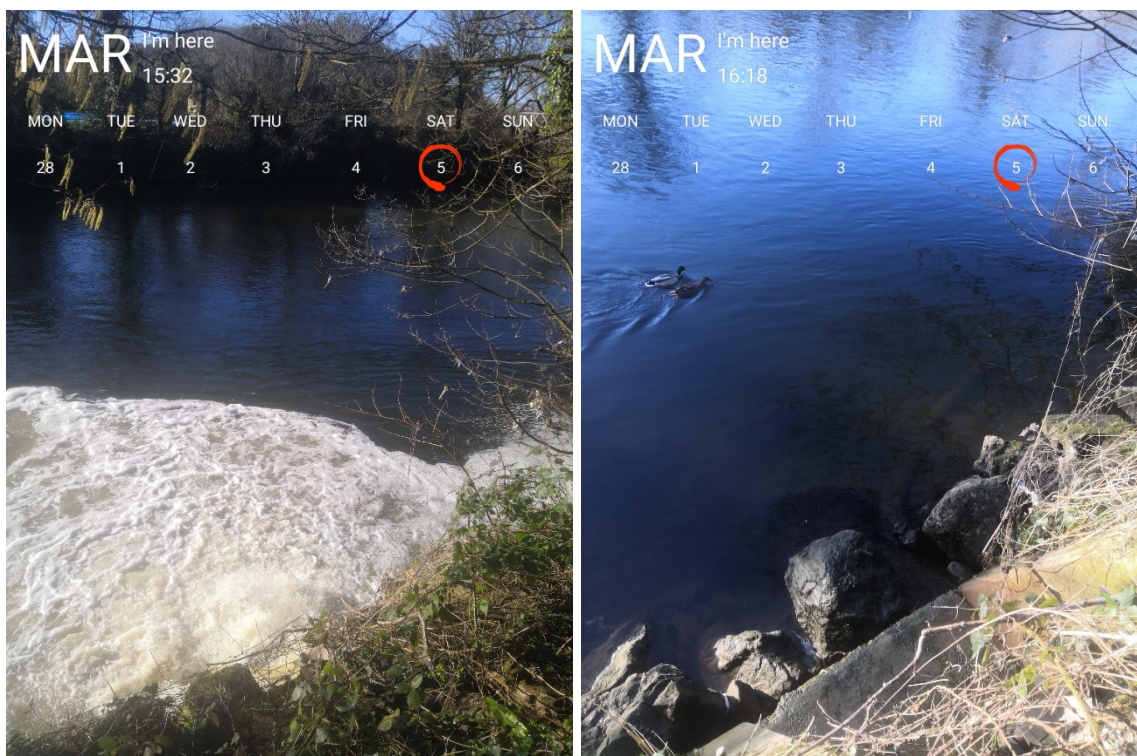
Update 1 - Crew and pollution tech en route to investigate

Update 2 - Sam Hampson attended site and found penstock to be out of position. There seemed to be a technical fault with the penstock as it wants to drive to fail safe mode. Penstock has been locked at the correct setting until we can determine the cause early next week. No further discharges. No visual impact once the discharge had stopped, photos to show. On duty officer Kelly informed over the phone and photos sent over. Levels in the river are still high following recent rainfall. Any queries please contact Sam Hampson.

Out of hours duty officer passed to Cardiff & Vale Environment team, with no further details.

Email correspondence with Sam Hampson stated " The penstock closure was caused by a full comms failure on the asset. We kept the asset manually locked at the correct setting until we could restore comms. The cause was unknown but was fixed by our electrician after a reset of the panel. I can only imagine there was some sort of third party failure which caused this, there could have been some sort of power outage or comms outage that was very short lived but our asset didn't automatically reset the comms after it happened.

We have amended the alarm level for a full comms failure and we have not had any issues with the comms since."



The incident was assessed as a 'low' level impact to water.

The permit for this asset is for the discharge of storm sewage only and this discharge was outside of the boundaries of the permit limits.

It has been categorised as a C3 non-compliance recorded following assessments made at the time of the incidents against conditions - 2.1.1 "The only activity authorised by the permit is the activity specified in schedule 1 table S1.1." Table S1.1 "Discharge of storm sewage at point of discharge".
