4. Details of our assessment

A brief site-familiarisation walkover was undertaken prior to the OMA Audit with no Permit condition breaches identified.

OMA Audit of Emissions to Air

OMA audit conducted returned a score of 72 % for monitoring of emissions to air.

The OMA audit identified that procedures are in place to achieve compliance with the limits and conditions of the Permit, but not all are procedures are documented.

Actions:

OMA 1E) ACTION 1. Ensure that responsible staff are adequately trained to enable them to understand the requirements of the permit, including the location of emission points and their monitoring requirements.

Training record evidence to be provided to Natural Resources Wales by the **2nd May 2023**.

OMA 2A) ACTION2.

The Operator should review the monitoring access ports and provisions against the requirements of M1 and instigate a programme of improvements identified. The Operator should seek permission from NRW if monitoring methods required are to be changed.

Please note, this was highlighted in the OMA which was carried out in the 2017.

Review to be complete by the 2nd May 2023.

OMA 4D) ACTION 3: The operator needs to implement suitable auditing procedures linked to the EMS to ensure:

- Personnel carrying out analysis/sampling do so in accordance with documented procedures
- Personnel carrying out monitoring do so in accordance with the SSP
- Monitoring and analytical reports provide sufficient detail to allow an audit trail back to the on-site measurement and process plant operating conditions

OMA 4E) ACTION4. The operator needs to implement suitable tracking procedures to provide assurances that the audit programme is being undertaken and that any procedural non-compliances are followed up and corrective actions put in place.

Roles and responsibilities of relevant members of staff tasked with carrying out the audits and tracking actions needs to be defined.

The absence of adequate procedures for the management of monitoring (as identified in this report) is a breach of permit condition 1.1.1 and attracts a **category 3** score.
