Product output and blast air were reduced to try to bring SO ₂ within limit but the readings remained high. A decision was taken to change the charge recipe on the morning of 30 th June to reduce sulphur sources such as coke, slag and cement. Process, Production and the Environmental Team are continually monitoring the situation.
