The solvent management plan was received on the 31st January 2023 as required by permit condition 4.2.5. The report contained the required information including calculations for emission points A5 and A37.

Further to this the final figures were reported as defined by permit condition 3.3.1, Schedule 3, Tables S3.1 & S3.4 for emission points to air A5 & A37. The results were compliant with the 3 % limit.
