4. Details of our assessment

The deployment application for PAN - 020277 at Little Bank Farm, Churchstoke, Montgomery states that waste was previously spread under PAN - 014783 issued on 05/08/2021 which expired on 04/08/2022. However, no pre-notification was received for this deployment as required by the permit condition below.

4.3.4 Natural Resources Wales shall be notified at least 48 hours but no more than 7 days in advance of the intention to commence spreading operations. In the event that spreading operations stop for more than 7 days the Natural Resources Wales shall be notified at least 48 hours but no more than 7 days in advance of the intention to recommence spreading.

The following non-compliance has been identified:

G4 - Reporting and notification to Natural Resources Wales - Permit condition 4.3.4 - C4

Waste was spread under Deployment PAN-014783 but no pre-notification to spread as required by permit condition was received.

Please note this score may escalate if this permit condition is breached again.
