### **Introductory note**

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation of environmental permits A (EPR/BP3494FC) and B (EPR/HP3694FJ) referred to in the status logs below and the replacement of those permits with a consolidated environmental permit.

In addition to the consolidation, the variation:

- Modifies the leachate level limits;
- Amends leachate, gas, groundwater and surface water monitoring schedules; and
- Updates the permit conditions to reflect that the facility is in aftercare and incorporates the agreed working plan for the aftercare of the facility

The schedules specify the changes made to the permit.
