4. Details of our assessment

This report details the site visit made on the 17th January 2023 to Penallta HWRC (Household Waste Recycling Centre), Permit number EPR-EP3795FQ. Officer Carla CURTIS attended the Penallta HWRC site at Penallta Industrial Estate, South Road, Hengoed, CF82 7ST for a routine site inspection and was accompanied by Scott JONES – Waste Treatment and Disposal Supervisor and Ricky VAUGHN – Waste Management Officer. The weather conditions were cold and sunny at the time of visit.

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

GENERAL OBSERVATIONS Penallta HWRC operate under a bespoke environmental permit based on standard rule set SR2010_No13. This site is used as a household waste transfer station with the waste being distributed to other companies / sites within the UK. The site was in operation at the time of the visit with numerous vehicles attending the HWRC. No waste of any type was stored outside of the permit boundary at the time of the visit.

WASTE ACTIVITIES - GENERAL All the waste storage containers were all clearly marked, and signage was in place to inform members of the public what each bin was for. There were also 2 employees on site directing traffic and informing members of the public the correct containers to use to segregate the waste correctly. This was witnessed by NRW officer at the time of the inspection.

The site was in good condition with no issues with the interceptor drainage system, which was fully operational at the time of the inspection. The general housekeeping of the site was kept to a good standard, the infrastructure on site was in good order with no cause for concern.

There is now a Reuse shop at the site this is a good opportunity for items once destined for the HWRC to be repurposed and reused. The site is closed Wednesday and Sundays, but the Reuse shop is open 7 days a week.

SITE SECURITY - the site has recently benefited from funding for site infrastructure improvements which have included a new welfare cabin, secure storage containers, updated CCTV and Fencing enhancements.

TECHNICAL COMPETENCY - The site TCM is Scott Jones. The latest WAMITAB certificate we have on the system for Scott expires 25/02/24.

WASTE RETURN SUBMISSIONS - These appear to be up to date and correct, the total quantity of waste accepted at this site must not exceed 25,000 tonnes per year. Based on the submitted waste return data for 2022, the total waste accepted was 3,970 tonnes which is within the sites annual threshold. NRW officer Carla CURTIS left site at around 11:45 am.

No permit non-compliances were identified on this visit and thus no breaches have been scored.
