4. Details of our assessment

NRW Officers Beth Bentley and Donna Muirhead visited Ty Mawr West Recycling, Ty Mawr West Quarry, Talysarn, LL54 6BA on the 6th October 2022 at 11.10am. This was an unannounced first visit to the site since it opened in 2020.

At the time of the visit the weather was dry, overcast and with little wind.

C4 Storage of Waste

Waste returns show 36,991 tonnes having entered the site in the last 2 years but only 1650 tonnes having left. It was of some concern that there were as yet no formal plans in place for the onward movement of the waste given that the site is already at half it's maximum capacity. The site would like to be able to treat the waste to the point of end of waste, they have been advised to seek assistance with this process soon.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during inspection, no excessive noise

F3 Dust/Fibres

Ground conditions were damp at the time of inspection. No dust on site.
