4. Details of our assessment

The companies waste returns were reviewed on the 25th January 2023 and it was identified that waste returns for Q1 2021 and Q2 2022 had not been submitted to Natural Resources Wales (NRW).

Company Director, Dewi Jones was contacted on the 25th of January 2023 by email to request submission of the missing returns.

Terry Parry, Company TCM submitted the missing waste returns to NRW at 20:16 on the 25th January 2023.

Terry Parry informed that the Q1 2021 waste returns had not been submitted as the Company at that time did not have a TCM and that Q2 2022 returns had not left his email outbox.

Section 4.2.2 of permit EB3697TF states that "within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter".

Please ensure that all future waste return submissions are sent to NRW in accordance with this requirement.

The following non-compliance has been identified:

G4 - Reporting and notification to Natural Resources Wales - Permit condition 4.2.2 - C4

Late submission of Q1 2021 and Q2 2022 waste returns.
