4. Details of our assessment

This Compliance Assessment Report follows the review of the following documents - Haf

Cell5bCQA plan V1.0 and Haf270a Cell5B lower design_AOL_ which were submitted to NRW on 06/01/23 and 09/01/23 respectively.

This is the latest in a long line of reports for the landfill as the new cell construction incrementally moves over the base of the quarry. As such there is little difference between this and previous approved plans other than a couple of small design details for which we require the operator to provide additional comments.

We note that the design proposes to build the northern side-slope at a profile of 1:2.5 yet the approved plan for Cell 5a (to which Cell 5b joins) has a side-slope profile of 1:3. It is not clear how the interface between these cells will work and so further details are required. The plan also indicates that the northern slope liner will be 1m thick until the excavation is above the marl when it will change to a 1m thick ASL overlying a 1m thick AEGB. The approved plan for Cell 5a stated that this was too complex a detail to construct and therefore Cell 5a was built with a double layer from the toe. The change of design thinking should be explained.
