Site confirmed there were no incidents or accidents at site during 2022. The flare stack is required to be monitored if the usage is >10% of the time. This was not required for 2022 as the flare stack was used 413 hours out of 8363 operational hours for the landfill gas engines ~4.5%. Annual reports accepted without further comment.
