4. Details of our assessment

Officer Carla CURTIS attended Lawn Civic Amenity Site in Rhymney on 17 January 2023 for a routine visit of permit EPR-QP3899FY. The weather conditions were cold and sunny at the time of visit. Officer CURTIS was accompanied by Scott JONES – Waste Treatment and Disposal Supervisor and Ricky VAUGHN – Waste Management Officer. The Rhymney site is closed every Tuesday and Friday. The site was closed to the public at the time of the visit.

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

GENERAL OBSERVATIONS This site is used as a household waste transfer station with the waste being distributed to other companies / sites within the UK. The site was closed at the time of the visit. No waste of any type was stored outside of the permit boundary.

WASTE ACTIVITIES All the waste storage containers were all clearly marked, and signage was in place to inform members of the public what each bin was for. The site was in good condition with no issues. The general housekeeping of the site was kept to a good standard, the infrastructure on site good order with no cause for concern.

SITE SECURITY The site has secure storage containers which were locked at the time of the visit, they also have 24 hour CCTV monitoring at the site and secure fencing.

TECHNICAL COMPETENCY The site TCM is Scott Jones. The latest WAMITAB certificate we have on the system for Scott expires 25/02/24.

WASTE RETURN SUBMISSIONS These appear to be up to date and correct, the total quantity of waste accepted at this site must not exceed 5445 tonnes per year. Based on the submitted waste return data for 2022, the total was accepted was 1948 tonnes which is within the sites annual threshold. NRW officer Carla CURTIS left site at around 11:05 am.
