4. Details of our assessment

Annual performance reporting 2022

Condition 4.1.3 of the permit requires a report on the performance of the permitted activities over the previous year. The 2022 annual report was received on the 27 January 2023.

Review of monitoring returns

Emissions to sewer - emissions to sewer are monitored for Mercury, Chemical Oxygen Demand and average flow. No Mercury was detected in the emissions to sewer and readings are below the emission limit value (Condition 2.2.2.8) and annual mass release limit (Condition 2.2.2.10). COD readings were taken in accordance with Condition 2.10.2, the readings remain consistent with previous years.

Energy Usage - energy usage remains similar to 2021.

Waste - waste disposal and recovery remains similar to 2021.

Water usage - water usage has reduced slightly 2021. The Operator has reported a change in water feeds and dosing system in Q4 that has helped reduce consumption.

Refrigerant Use - refrigerant consumption has decreased compared to 2021.

EMS Summary Report

An EMS summary report was submitted in accordance with condition 4.1.5 on 27 January 2023.

There are no non compliances in respect to the above, and the site is compliant with the permit reporting requirements.
