This Compliance Assessment Report relates to the annual monitoring and reporting requirements in permit no. BX4666IZ.

Air Emissions A1.

No exceedances of emission limit values have been reported.

Please note, a result of 0.9 mg/m^3 was provided for particulate matter at emission point A2 which has an emissions limit for particulates of 1 mg/m^3 . This is within 10 % of the limit value.

Permit condition 4.1.2 requires that the following performance parameters (specified in Table S4.1) to be recorded and reported to Natural Resources Wales every 12 months: fugitive emissions (percentage of solvent input), organic solvent consumption (tonnes/year). This data has been provided as part of the annual returns submission.

The requirement to submit these parameters was reinforced to the operator within assessment report CAR_NRW0039358 which was issued on the 30th January 2022.

A category 4 score has been applied against permit condition 4.1.2 (G4 – Reporting and Notification to Natural Resources Wales).

Action 2: Provide the information specified in Table S4.1- fugitive emissions and organic solvent consumption to Natural Resources Wales by the 1st March 2023.
