4. Details of our assessment

Annual monitoring returns for 2022

Requirements: Permit Condition 4.2.2 requires that a report on the performance of activities over the previous year shall be submitted by 31st January each year.

Findings: Reporting forms for water, energy usage, and raw materials were received on 30/01/2023 in accordance with Permit requirements.

The production volume of 16,427 tonnes for 2022 was down compared to 2021 (18,163 tonnes).

Raw material usage for 2022 was 19,727 tonnes, down on the 23,768 tonnes used for 2021 reflecting reduced production.

Water usage of 9.5 m³/t in 2022 is significantly increased compared to 6.55 m³/t in 2021 demonstrating reduced resource efficiency.

Energy usage for 2022 of 2.56 MWh/t was very similar to 2021 (2.51 MWh/t). The Operator has installed solar panels at the site which commenced generation in November 2022.

Notifications

On the 19/03/22 the operator informed NRW of smoke inside the factory and that the fire service had been called in accordance with Permit Condition 4.3. This was followed up with a part B report as required by the permit confirming that smoke was confined to the laundry room as a result of a faulty washing machine.
