The inspection and discussions were conducted during the process walk-around. Some very interesting points were raised regarding the challenges faced by responsible operators in this business sector.

The hazardous waste treatment area was, as usual, clean, tidy and in generally good condition.

There was a crack in the concrete block bund which, while posing no real risk at the moment, should be repaired and made good in the near future.

Custom-made hazard warning labels have been attached to all the IBCs in use in the area where wastes that are being bulked up prior to disposal are stored. Most have had their original labels removed or obliterated. One IBC was seen that was labelled as waste oil, but the hazard warning label on the IBC itself was for a different material.

Action: *Ensure IBCs are only marked with one hazard label that is correct for the contents.*

The visit was very useful for all concerned and NRW would like to thank all the GDE personnel involved for giving up their valuable time to give us such an informative tour.
