A sample that Natural Resources Wales took of this discharge for permit compliance purposes on the 13th of December 2022 had a solids result of 60mg/l, whereas the permit limit is 30mg/l.

This is the third sample to have breached it's solids limit during 2022.

Please note that further permit breaches may result in Natural Resources Wales taking a higher level of enforcement against the company.
