4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to comment upon the monitoring returns and annual report that were recently submitted to Natural Resources Wales.

Q4 Monitoring Returns

Monitored data was completed as required by Permit Condition 3.5.1, Schedule 3(b), Tables S3.1, S3.2, S3.3 & S3.4. Reporting was submitted as per Permit Condition 4.2.3 and was received by email on 25/01/23. No issues with the submitted data were identified. In the bundle of quarterly reporting although the individual sheets were correctly dated each sheet was named incorrectly with a file name pertaining to "Q2". Resubmission is *not* required in this instance however, please ensure in the future that file names reference the reporting quarter to which they relate.

Annual Reporting

The Annual Report was received in the same submission. The submission of the Annual Report satisfies Permit Condition 4.2.2 in combination with the submitted annual reporting forms. No issues were identified in the data. The Annual Report itself discusses the monitoring results, weather trends and operational methodologies and gives a good feel for the operation of the site.

The report mentions that certain chemical species are either below the limit of detection or within the historical range. To assist the trending of these parameters, in future annual reports, state which species are within these historical ranges, the historical range and the highest value for that species for the reporting year. This will assist with trending and help to satisfy the interpretive review component of Permit Condition 4.2.2(a)
