This was an unannounced visit carried out by Donna Muirhead (Industry & Waste Regulation Officer) and Berwyn Williams Industry & Waste Regulation Team Leader (NW).

Weather conditions throughout the visit were dry, overcast and cold.

Upon arrival the entrance and yard was a bit muddy this was due to a lot of recent rain.

Site was very quiet and site operatives processing waste within the waste transfer building.

All other wastes were stored in designated skips within the building. This area was generally tidy and organised not a lot of waste on site due to the quiet period after Christmas.



No issues were noted relating to noise, odour, litter or pests.

Site diary was checked and transfer notes, no issues were noted.
