4. Details of our assessment

This was an unannounced visit carried out by Donna Muirhead (Industry & Waste Regulation Officer) and Berwyn Williams Industry & Waste Regulation Team Leader (NW) accompanied by Paul Allport.

Weather conditions throughout the visit were dry and overcast.

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

No issues noted whilst walking around the site, the site was generally tidy with all wastes stored appropriately. The yard, including the scrap metal storage areas and ELV depolluting workshop were inspected, no issues noted.



There was minimal amount of metal stockpiled on the hardstanding area on site, which included a number of baled ELV's.

9th December 2021 there was a fire on site. It was recommended by the FRS officer that Allport staff should attend external training on this subject. Paul confirmed that training has now been completed.

Site diary, and transfer notes were inspected, no issues noted.
No issues were noted relating to noise, odour, litter or pests.
