4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to record breaches of the environmental permit arising from the exceedance of permitted emission limits during **2022**

Annual Reporting

The Annual Report, comprising the required submission under condition 4.2.1 of the environmental permit, was received from the Operator. NRW have not compliance assessed this submission as part of this Compliance Assessment Report, however we note the recommendations in Section 6.2, which should be implemented and reported on.

Schedule 6 Submissions

A Schedule 6 notification submitted to NRW on 24 October 2022 gives the measured mecoprop result at monitoring point NACW228 on 12 October 2022 as 0.055 µg/l. This is an exceedance of the permitted emission limit of 0.000055 µg/l and represents a non-compliance with the environmental permit.

This breach has been assigned as a non-compliance category C3 has been recorded against compliance sub-criteria E2 Emissions – Land and Groundwater.

A Schedule 6 notification submitted to NRW in Q1 2022 gives the measured mecoprop result at monitoring point Cell 1/2 on 11 January 2022 as 108 µg/l against a “limit” of 71 µg/l.

A Schedule 6 notification submitted to NRW in Q4 2022 gives the measured mecoprop result at monitoring point Cell 1/2 on 24 October 2022 as 98.6 µg/l against a “limit” of 71 µg/l.

Permit variation 004 clarified that this ‘limit’ was in fact a ‘control level’ which is not a breach. The control level is placed as a tracking tool to enable site and the regulator to monitor the leachate quality coming from the site. Reference EPR CP3735PB V004 table S4.9 specification 2 where ‘(exceeded) trigger levels shall be notified in writing within 7 days of the result being received by the operator’. Therefore the Schedule 6 submissions are not a breach of the permit, but a warning that the control level has been breached which requires further management.

Action: Operator to complete review of mecoprop trends across site monitoring network and submit to NRW.
