4. Details of our assessment

An announced site inspection was conducted by Sally Wakeford and David Morgan on 25 January 2023. We were accompanied on site by Tony Davies and Rhiannon Davies of TD

Tyres.

First Inspection

This was a first site inspection since the permit was issued in October 2022, and as such we went through the “First Inspection Checklist” to discuss requirements of the permit, including waste returns, TCM cover, compliance scoring, Duty of Care etc.

Following the inspection, information was sent to you on 25/01/2023 regarding signage on site and waste returns.

Technically Competent Manager

Tony Davies is in the process of completing the WAMITAB course for Technical Competence, the site has been given a grace period of 12 months from permit issue for this to be in place. This should be completed by 17 October 2023. Please provide the certificates once complete.

Waste Returns

Waste returns should be submitted quarterly, within one month of the end of each quarter, a summary of which is found below:

Q1 – January – March, submitted by end April

Q2 – April – June, submitted by end July

Q3 – July – September, submitted by end October

Q4 – October – December, submitted by end January.

The Q4 2022 returns are due, however we are aware that these will be late as you only received the spreadsheet on 25 January.

If you have any questions regarding the waste returns or any other subject in this report, please don't hesitate to contact Sally Wakeford.

Other:

You should review your permit, Environment Management System to ensure you are aware of all conditions within them, including, for example, the requirement for you to notify NRW of any breakdowns or malfunctions.

You should also ensure that staff are aware of the requirements of the permit, should the management personnel be unavailable for any reason.

On the next inspection NRW will review the storage of tyres on site, to ensure they are stored in line with the FPMP, including fire breaks.
