4. Details of our assessment

Egan Waste annual returns

Egan Waste submitted their annual treatment and performance parameters to NRW on the 20.01.2023.

Egan Waste recovered 323 tonnes of oils in 2023 and generated 1039.5m³ of wastewater.

Water usage for the site was 385m³ in 2023. Electricity use was 34.977 MWh in 2023.

The annual reporting is compliant with the permit.

Quarterly Reporting 2022

Q4 Returns

The site received a total of 767.8 tonnes of waste in Q4 and removed a total 744.5 tonnes.

Q3 Returns

The site received a total of 805.9 tonnes of waste in Q3 and removed a total 845.1 tonnes

Q2 Returns

The site received a total of 772.5 tonnes of waste in Q2 and removed a total 520.6 tonnes

Q1 Returns

The site received a total of 655.9 tonnes of waste in Q1 and removed a total 762.9 tonnes

Emissions Monitoring.

Egan waste has not submitted monitoring of S1 for 2022. This is due to a delayed decision by NRW on what emission limits can be accepted to the sewer network. Egan Waste has also not submitted the final emissions inventory to S1 but is working towards completing the inventory. The non-compliance and score are suspended because of Egan Wastes efforts to be compliant with the new WT Bref permit.

Action. Site to complete the emissions to sewer inventory and musty take a minimum of 13 samples.
