4. Details of our assessment

On the 3/11/2022 you informed NRW of a leak from storm tank 5 at Gowerton WWTW. The leak resulted in a Low Level pollution to a small watercourse just outside the works boundary.

It was established that the leak had occurred due to 3 defective flap valves on the storm

tank .

Compliance assessment with Condition 2.2 The Site

Permit condition 2.2 - The discharge activities shall take place at the discharge point marked on the site plans at schedule 7 to this permit, and as listed in table S3.2; and, the operating techniques that are the subject of conditions prefixed by 2.3 shall be applied at the locations shown, or otherwise described, in schedule 7.

Storm The discharge that occurred from the storm tank on the 3/11/2022 was to a location other than the permitted discharge point so it was not compliant with permit condition 2.2. Please carry out the Action required in this compliance report to prevent this from occurring again.

Compliance assessment with condition 4.3.1 (a) Notifications.

Permit condition 4.3.1 - Natural Resources Wales shall be notified as soon as reasonably practicable following detection, within the site of the regulated facility of:

(a) any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution
