4. Details of our assessment

A solvent use report was received in accordance with permit condition 4.1.2, S4.1 and as required by CAR form NRW0041031 which was issued on the 6th February 2023.

The operator has disclosed that 1960 litres of solvent was used on the 'Optimal Surface Cleaning line' stating that 967 litres of solvent was committed to waste while 983 was lost as fugitive emissions. This represents approximately a 50 % loss of solvent used as fugitive emissions.

Permit condition 2.2.4.2 states that ***"Fugitive emissions of organic solvent from the surface cleaning [activity relating to A11 in Table 2.2.1 of this permit] shall not exceed 20 % of the solvent input. Fugitive emissions in this respect shall be determined based on the methodology in the Solvent management Plan guidance. As provided in Annex III of the Solvent Emissions Directive."***

A category 3 score has been applied under E1- Emissions to air.

Action 1: Review the site activities in accordance with the solvent management plan by the 31st March 2023.
