4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised to review the 2022 Annual Report submitted to Natural Resources Wales (NRW) on 30th January 2023.

The Annual Report has been submitted to satisfy Permit Condition 4.2.2 and was submitted within the required timeframe and covers the requirements required by the condition. Furthermore, the report covers areas of energy efficiency, use of raw materials and waste minimisation. These areas address Permit Conditions 1.2.1, 1.3.1 and 1.4.2 respectively at an annual frequency which, is over and above that required by the four year frequency defined by the permit conditions.

Monitoring data was presented and discussed in the annual report as required by Permit Condition 4.2.2(a). Monitoring data was submitted earlier in the year as required by Permit Condition 4.2.3 and was discussed in CAR_NRW0040803.

The operator has experienced high customer demand which, has led to an increase in the use of precursor materials to enable higher production levels. Due to changes in practices a decrease in usage of some parameters has been achieved. In this regard LPG and towns water usage has seen a decrease since the last report. In addition, working practices have resulted in a decrease in reported CO₂ generation.

The report mentions the intention in 2023 to replace the nitric acid tank and associated scrubber. The operator is reminded that, dependant on the final plan, this is likely to require a variation to the permit before the new acid tank and scrubber system can be used.
