4. Details of our assessment

Self report from Sam Taylor (FCC) Environmental and Sustainability manager of permit breach at Swansea Road discharge point.

Siltbuster switched off for previous week due to limited precipitation. Higher temperatures on the 25th led to snow melt entering the pond. As a result, the siltbuster was switched on however the motors on the mixers failed.

As a result, silty water seeped over the pond and into the watercourse causing discolouration. By the morning of the 26th the majority of the snow had melted and the pond had stopped overtopping.
