4. Details of our assessment

An unannounced site inspection was conducted by Sally Wakeford, accompanied by Lara Moggridge on 20 January 2023 and accompanied on site by the operative present, apologies for not recalling his name.

The site was secure on arrival and opened by the operative. The site was well organised. With clear separation of aggregate types. The operation was described stating that when the skip was full, but there was no customer for this material, it was added back into the pile for regrading along with other incoming wastes.

The aggregates produced appeared consistent within their piles and of good quality, however no paperwork for testing of these aggregates was viewed to ensure they met with the WRAP Quality Protocol for Aggregates to meet end of waste. At the next inspection NRW officers may request this documentation.

The quarantine skip was seen in use.
