Quarter 4 Waste Returns

G4 Reporting and notification to Natural Resources Wales

Waste returns have been received for quarter 4 on the 30th of January 2023 as required by permit condition 4.2.2 and a review of the waste returns has been undertaken.

No issues with the waste returns have been identified.

Annual Monitoring Data

Permit condition 3.1 requires that the operator will undertake the monitoring specified in table 3.1, it requires that Annual monitoring will be undertaken on engine stacks.

The site has been operational for less than 12 months, becoming operational in April 2022. However, data for emissions monitoring which corresponds to 2022 is required. The permit specifies that a “year” means calendar year commencing on the 1st January.

Action 1: Perform air monitoring and submit the data to Natural Resources Wales by the **17th March 2023**.

The operator is advised that the data mentioned above will correspond to the air monitoring data for 2022 and that monitoring for 2023 should be performed on a separate occasion, by 31st December 2023. Data should be submitted to Natural Resources Wales by the 31st January 2024, in accordance with permit condition 3.5.2.
