3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Waste Returns

Permit Condition 4.2.3(b), Schedule 4(b), Table S4.3 & Permit Condition 4.2.5 require the operator to submit quarterly waste returns to Natural Resources Wales (NRW) within 28 days of the close of the preceding quarter. Waste returns for Q4 were received within the stipulated timeframe with no issues identified.

Monitoring Returns

Permit Condition 3.3.1 requires the operator to undertake monitoring as specified in Schedule 3(b), Tables S3.1, S3.2. The results of the specified monitoring are required to be reported to NRW in accordance with Permit Condition 4.2.3, Schedule 4(b), Table S4.1. The Q4 monitoring reports for emissions to water between 01/10/2022 to 31/12/2022 were received within the relevant timeframe. The returns for emissions to air and water this reporting quarter were reviewed with no issues identified.

Permit Condition 3.3.1 also requires monitoring of Schedule 3(b), Table S3.3. Table S3.3 lists annual emission limit values for the listed parameters. The submitted Water 1 form contains the rows for these parameters but no data has been submitted. The reviewing officer is unable to assess if annual elv breaches have occurred or not. This is a breach of reporting and is scored below.

Score: (G4) Reporting & Notification to NRW. Permit Condition 4.2.3. CCS 4.

Action 1: Submit the missing data required by Tables S3.3 & S4.2 to NRW.

Annual Report

Again only data and no annual report has been submitted by the operator despite the CCS score and action applied on Compliance Assessment Report Form CAR_NRW0039261 last year.

Permit Condition 4.2.2(a) requires *a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data*. Only data was received from the operator. The operator should for each annual report submission review and comment upon data trends (quarterly and yearly) highlighting and issues with monitoring, and improvements or deterioration in recorded emissions. This omission has attracted a CCS score and action.

Score: (G4) Reporting & Notification to NRW. Permit Condition 4.2.3. CCS 4.
