4. Details of our assessment

This was an unannounced visit carried out by Donna Muirhead (Industry & Waste Regulation Officer) and Berwyn Williams Industry & Waste Regulation Team Leader (NW) accompanied Phoenix employee.

Weather conditions throughout the visit were dry and overcast.

Upon arrival the entrance and yard was free from any mud/debris and was very clean and tidy.

No issues noted whilst walking around the site was very quiet at the time of the visit.

The yard, including the scrap metal storage areas and ELV depolluting workshop were inspected with no issues, the site was generally tidy with all wastes stored appropriately. no issues noted.



There was some baled ELV's stored as well as stockpiled scrap metal. None of the depolluted ELV's were inspected.

There was a pool of standing water on site, It was understood that work had taken place to rectify this, however the concrete used wasn't strong enough and that the work was getting re-done.

Some debris and oil were present near the drain, and would benefit from being kept clean.



No paperwork was inspected

No issues were noted relating to noise, odour, litter or pests.
