This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the Annual Report and Q4 Monitoring Returns.

1. Q4 Monitoring Returns

Q4 2022 (October - December) monitoring results were submitted to NRW on 30/01/23 in accordance with Condition 4.2.3

1.1 Emissions to Water - Emission Point W1

Emissions to water for Q4 were tested on the 20/10/2022, 15/11/2022 and 15/12/2022. All parameters were within the emission limit values (ELVs) defined in the Permit (S3.2).

2. Annual Report

The Annual Report was submitted to NRW via email on 30/01/23 as required by Permit Condition 4.2.2. The Annual Report provided all the information as required under the Permit.

2.1 Annual Production

Annual production is similar to the previous year.

2.2 Performance Parameters

No non-hazardous waste production is reported for 2022, hazardous waste generated is significantly lower than 2021. Clarification is required regarding how waste streams are generated and reported.

All other reported parameter contained the expected data, with no apparent issues.

Action: Review reporting mechanism for waste and confirm and /or comment on the waste streams generated and how they are reported by 27 March 2023.
