4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment upon the Annual Monitoring Returns and Annual Report.

1. Annual Monitoring Returns

The annual monitoring returns were submitted to NRW on 30/01/23 in accordance with Condition 4.2.2.

Emissions to air were sampled and tested for particulates between 22 November and 15 December 2022 for emission points A3 to A7 (inclusive). All results for emission points are below the emission limit values set in the permit (Table S3.1).

2. Annual Report

The annual report was submitted to NRW on 30/01/23 in accordance with Condition 4.2.2.

Reported parameters are typically in line with previous years. A slight increase in total water usage and water per unit of output on 2021 figures is reported. A slight decrease in total energy use and carbon dioxide (CO₂) produced and a lower CO₂ per unit of output is recorded compared to 2021 figures.
