Part A / Bs

A number of notifications have been received by NRW in relation to refrigeration gases lose. The quantity lost on each occasion is relatively small. The cause of the leaks appear to be generally linked to ruptured or fractured pipes on the condensers.

The Operator should review existing maintenance schedules to ensure that they are appropriate and pick up on potential issues to stop further releases from occurring. When a leak occurs are any assessments of other similar plants carried out to ensure minimisation of further issues?

No permit breaches have been assigned to these notifications.
