4. Details of our assessment

The inspection was carried out as part of our planned water quality compliance inspections for '22/'23. This site was selected due to the WFD status of Llyn Cwellyn. The weather at the time of the inspection was dry and sunny.

Observations made:

1) The screen at the inlet required some repair due to missing bars.



2) The scumboard on the left primary tank had fallen from it's vertical position.



3) Plastic from sanitary products was visible on the filter bed. Please ensure that the filter bed is regularly checked and cleared of any plastic litter.

4) There were some tree branches over hanging on to the filter bed. This could become an issue if the branches were to fall onto the filter bed. Some maintenance of the trees branches required to prevent future issues.

5) There was an issue with distribution of effluent in the humus tank with effluent being discharged to the left tank at a disproportionate rate to the right.

6) We were unable to access the final outfall during the inspection. The gate leading to the outfall could not be opened. Some maintenance to the gate is required. Once access is gained, a photo showing the outfall and the river Gwyrfaï should be sent to NRW officer.

The site was last inspected on 29/9/16 (CAR_NRW0031429) and a comment was made that an infiltration survey of the sewer catchment would be beneficial. Was this carried out?

The works is old and there is no electricity serving the site. Is there any plan for investment to the works in the future?
