4. Details of our assessment

On 23/11/2022 a self report was received by NRW from DCWW explaining that Coslech WWTW was experiencing an issue with an electrical phase which had caused the pumps to fail. This was later attributed to an unplanned power cut in the area, confirmed by National Grid. Generator was brought to site to bring site back on line whilst awaiting electricity supply to be restored.

Discharge from site in accordance with condition 2.3.1, the discharge activity occurred

during an emergency which includes the definition of electrical power failure, via the designated discharge point. NRW considers the discharge compliant with the permit conditions.
