4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment upon the Annual Performance Report and Annual Monitoring Returns.

1 Annual Performance

The Annual Performance Report was submitted via email to NRW on 24/01/23 in accordance with Condition 4.2.2. The annual report has been reviewed and the following salient points noted:

- Total waste and non-recycled waste increased in absolute terms annually by 33.2% and 36.9% respectively. The increase is linked to build rate recovery and an increase in unplanned chemical waste from treatment facilities for quality reasons.
- A substantial decrease in energy consumption by 10.55% in absolute terms.
- VOC usage increased by 14.65% in absolute terms when compared to 2021 data. The increase is linked to build rate recovery following COVID19, this represents a reduction of 4.23% when normalised.
- Water consumption increased by 20.58% in absolute terms when compared to 2021 data. The increase is linked to build rate recovery following COVID19, this represents a reduction of 12.2% when normalised.

2 Air Emission Monitoring

Air emission monitoring returns were submitted to NRW via email on 25/01/23 in accordance with Condition 4.2.2. An air emission monitoring survey for oxides of nitrogen (as NOx), as required by Table S 3.1, was undertaken between 24 and 26 January 2023.

A number of the combustion plant were not operational due to lack of demand and were not sampled. All operational emission points which were sampled were within the respective permitted limits of 200 mg/m³ and 500gm/m³. The monitoring period was outside the timeframes specified within the Permit and has been scored a **C4 breach of Condition 3.5.1**

3 A Solvent Management Plan

A Solvent Management Plan was submitted to NRW via email on 25/01/23. The solvent management plan summarises a number of VOC reduction initiatives introduced during 2022. The 2022 Industrial Emissions Directive (IED) reduction scheme targets shows the following:

- Coating Activities VOC (gross) was 73.1 tonnes, this equates to 59.73% of the 122.38 tonne target.
- VOC waste was 2.32 tonnes.

- Coating Activities VOC (net) was 70.77 tonnes, which equates to 57.83% of the target.
