4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Regulating Natural Resources Wales (NRW) officer to comment upon the Annual Report and Q4 Monitoring Returns.

1. Q4 Monitoring Returns

Q4 2022 (October - December) monitoring results were submitted to NRW on 24/01/23 in accordance with Condition 4.2.3.

1.1 Emissions to Water - Emission Point W1

Emissions were tested for Flow, pH, Suspended Solids, Chemical Oxygen Demand, Iron, Chromium, Mercury, Nickel and Zinc. Noted that all measured parameters are below permitted emission limit values (ELV).

2. Annual Report

The Annual Report was submitted to NRW via email on the 24/01/23 as required by Permit Condition 4.2.2.

2.1 Emissions to Air

Combustion plant reporting emissions for the period 01/01/22 - 31/12/22, were reported as follows:

- Emission points A1, A2, A3 and A4 NOT OPERATED, therefore no results reported.
- Emission points A5, A6, A7 and A8 (gas firing conditions only), were monitored for oxides of nitrogen as NO₂ and carbon monoxide (CO), all recorded emissions were below the ELVs

Galvanising line reporting emission points were monitored for NO₂ and CO for the period 01/01/22 - 31/12/22 and were reported as follows:

- Emission points A31, A32, A33
- Emission points A35, Galvanising Furnace No.6 reported data did not raise any issues.

Regenerative Thermal Oxidiser (RTO) line emission points were monitored for NO₂, CO and Volatile Organic Carbon (VOC) for the period 01/01/22 - 31/12/22 and were reported as follows:

- Emission points A12, A12A, A18 (COBRA) and A21 all recorded emissions were below the ELVs
- Emission points A13, A14 and A15 all recorded VOC emissions below the ELVs.

2.2 Fugitive Emissions

Fugitive solvent emissions calculated for Colour Coat lines 2 and 1 with average emissions of 1.06% and 1.69% respectively. Fugitive solvent emissions in compliance with the

requirements of Industrial Emissions Directive.

2.3 Annual Water & Energy Usage, Waste Disposal & Recovery

Annual Energy consumption has reduced in comparison to 2021 reported data. Potable water use has increased slightly and non-potable water use decreased in comparison to 2021 the report. A significant reduction in non-hazardous waste production for 2022, with hazardous waste quantities remaining generally unchanged. No notable changes in other parameters recorded.
